STATEMENT OF WARRANTY

J. Q. Tex, Inc. warrants to the original purchaser of its products, that the products manufactured by it will be free from defects in material and workmanship on the STRUCTURAL FRAME ONLY for a period of three (3) years beginning on the date of purchase. All other components and paint manufactured by J. Q. Tex, Inc. will be warranted for a period of one (1) year from the date of original purchase.

WHO IS COVERED

This warranty is extended to the original purchaser only and does not extend to any subsequent person(s) to whom ownership of the trailer may be transferred.

WHAT IS COVERED

This warranty does not apply to trailers that have been altered or modified in any manner, nor shall it apply to any damage resulting from unreasonable or negligent use, nor shall it apply to damage resulting from failure to provide reasonable maintenance. Salt water use of non galvanized trailers will void this warranty. Further, equipment manufactured by others and incorporated by J. Q. Tex, Inc. into its products are not warranted by J. Q. Tex, Inc., but are sold exclusively under any warranty of the manufacturer of the incorporated parts and then only to the extent such other warranty is enforceable and transferrable by J. Q. Tex, Inc.

HOW TO MAKE A CLAIM

Immediately upon discovering a potential defect, the original purchaser should send written notification of the potential defect to: J. Q. Tex, Inc., at 1033 East 5th St., Mishawaka, Indiana, 46544, describing the potential defect, stating the date and place of purchase and providing J. Q. Tex, Inc. with an address and phone number where the original purchaser can be contacted. To insure receipt, such notification shall be sent to J. Q. Tex, Inc. certified mail, return receipt requested.

To make a claim pursuant to this warranty, the original purchaser shall return the product to our factory at the address stated above, freight pre-paid, or to the location directed by J. Q. Tex, Inc. within three (3) years from the date of purchase. J. Q. Tex, Inc. shall determine within 14 days thereafter whether or not the product was defective when delivered to the original purchaser and notify the original purchaser as to the applicability of the warranty or its reason for declining to repair or replace the product under the terms hereof.

LIMIT OF WARRANTY

Except as specifically stated in this limited warranty, J. Q. Tex, Inc. makes no other warranties, expressed or implied, and all implied warranties, including the warranties of merchantability and fitness for a particular purpose, are limited to three (3) years from the date of purchase and thereafter all such warranties of merchantability and fitness for a purpose are disclaimed and excluded. The liability of J. Q. Tex, Inc. under this Limited Warranty is limited to repair or replacement of the defective part, all claims for incidental, consequential or resulting in damages are specifically excluded. Some states do not allow limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you. The return of the Owner's Registration Card by the original purchasers is a condition precedent to this limited warranty. Failure to return the Owner's Warranty Registration Card within thirty (30) days after the date of purchase may void the Limited Warranty provided herein. This three (3) year limited Warranty is the exclusive warranty of J. Q. Tex, Inc. The sales personnel or other employees of J. Q. Tex, Inc. dealers are not authorized to make warranties concerning J. Q. Tex, Inc. products and no oral statements shall constitute a warranty by J. Q. Tex, Inc. This limited warranty gives you specific rights and you may also have other rights which vary from state to state.
